Overview

Why did Montenegro not issue energy permits?

Montenegro's Ministry of Economy did not plan to issue energy permits in its Energy Licensing Plan for 2019 because the country is already close to reaching its national target of 33 percent of produced energy coming from renewable energy sources (RES) in final energy consumption. The passage does not provide information on why Montenegro did not issue permits for other reasons.

Do public procurement and concession laws apply in Montenegro?

When selecting a strategic partner and concluding a project implementation agreement, public procurement, public-private partnership, and concession laws do not apply. The adoption of a comprehensive law regulating renewable energy usage in Montenegro marks a significant and necessary step towards a green transition.

What is the market premium system in Montenegro?

The market premium system is being introduced gradually, and during the transitional period, which lasts until Montenegro's electricity market is merged with the European day-ahead market (expected by 31 December 2025), privileged producers have the right to physically sell electricity to an authorised contractor or the market operator.

Can Montenegro enact a strategic project?

The government of Montenegro, upon the Ministry's proposal, may enact a by-law for the implementation of a strategic project in special cases where additional measures are necessary to achieve goals set out in the national climate plan or international agreements.

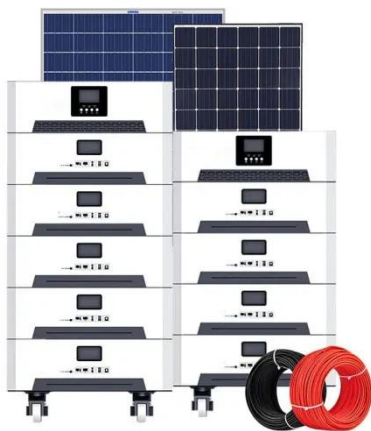

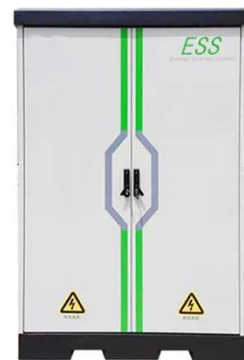
