Are lithium batteries safe to ship?

Improperly packaged lithium batteries can ignite, causing fires that are difficult to extinguish and pose a significant risk to the safety of transportation workers and the general public. Other battery types, such as alkaline or nickel-metal hydride (NiMH), are generally considered safer to ship.

Can I ship a lithium ion battery by air?

For this reason, any battery that is suspected or known to be defective (swelling, corroding or leaking, for example) is not permitted for shipping within the DHL Express network. When you're shipping lithium-ion batteries by air, it's essential to follow specific regulations regarding their state of charge

(SoC).

Are wet batteries safe to ship internationally?

Like lithium batteries, there are strict regulations to follow when shipping wet batteries internationally. An IATA Dangerous Goods label must be attached, along with the correct UN number and shipping name for the particular type of batteries.

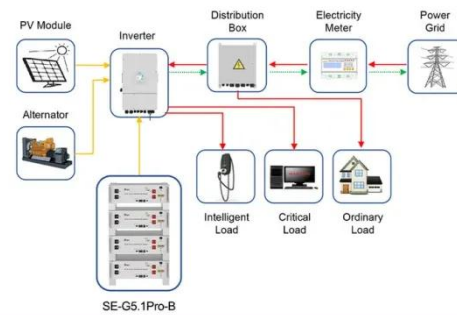
